Dear Dealer,

CaliFur is approaching, and we are now accepting applications for dealer's room space. We are a relatively new convention, but following in the footsteps of a long established convention in the Southern California area, so we're expecting a good turnout. The dates for CaliFur are May 4th through 6th of 2007. We will again be located at the Holiday Inn Costa Mesa, in Costa Mesa, California. You can also get more details by checking out the website at <http://www.califur.com>.

- Tables are \$60 each (until January 2nd, 2007) and include one membership per table (\$25 for an additional membership – we need real names for each membership – if you don't give a real name, we can't accept the application); since table space is limited we are initially limiting space to one table per dealer. At the moment, we are planning on using 6' tables (it all depends on what the hotel has available for us - it will NOT be smaller than 6'). If you feel your needs will require an addition table, contact us and we will see if it can be arranged.
- A few words about California State Sales Tax laws. All dealers must fill out and sign the enclosed form BT-410-D Swap Meets, Flea Markets, or Special Events Certification form. On this form please note Section 3. *STATUS*. If you hold a California State Board of Equalization Seller's Permit, enter your account number in the space provided. If you don't have a Seller's Permit, and aren't either selling exempt property or your sales are not Exempt Occasional Sales, then you must get a Temporary Seller's Permit from the California Board of Equalization. When you receive your permit number, let us know and we can verify and record it for our records. If we do not have a number on file, we cannot allow you to set up. After the convention, you may be required to file a sales tax return with the forms the BOE will provide you. Additional information and forms may be found at www.boe.ca.gov - the official website of the BOE.

To apply for space at CaliFur, please fill out the enclosed dealer's registration form and your cheque made payable to *CaliFur*, and send it to the address above. Please note that in order to ensure space, you will need to apply for space early - we expect to sell out fast. If your application comes after we are full, you will be put on a waiting list. If you have questions, you can send them to the address above, or to dealers@califur.com
